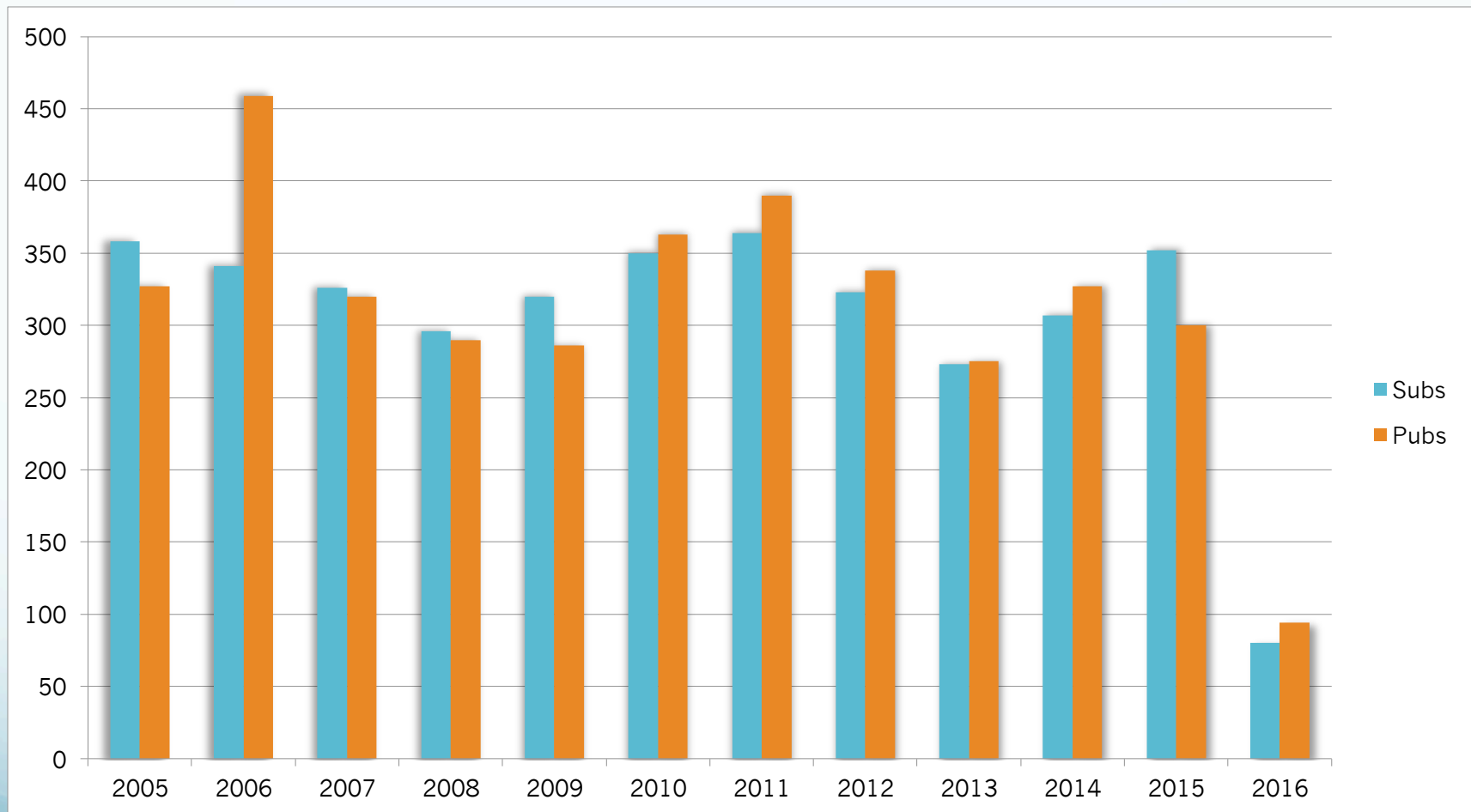

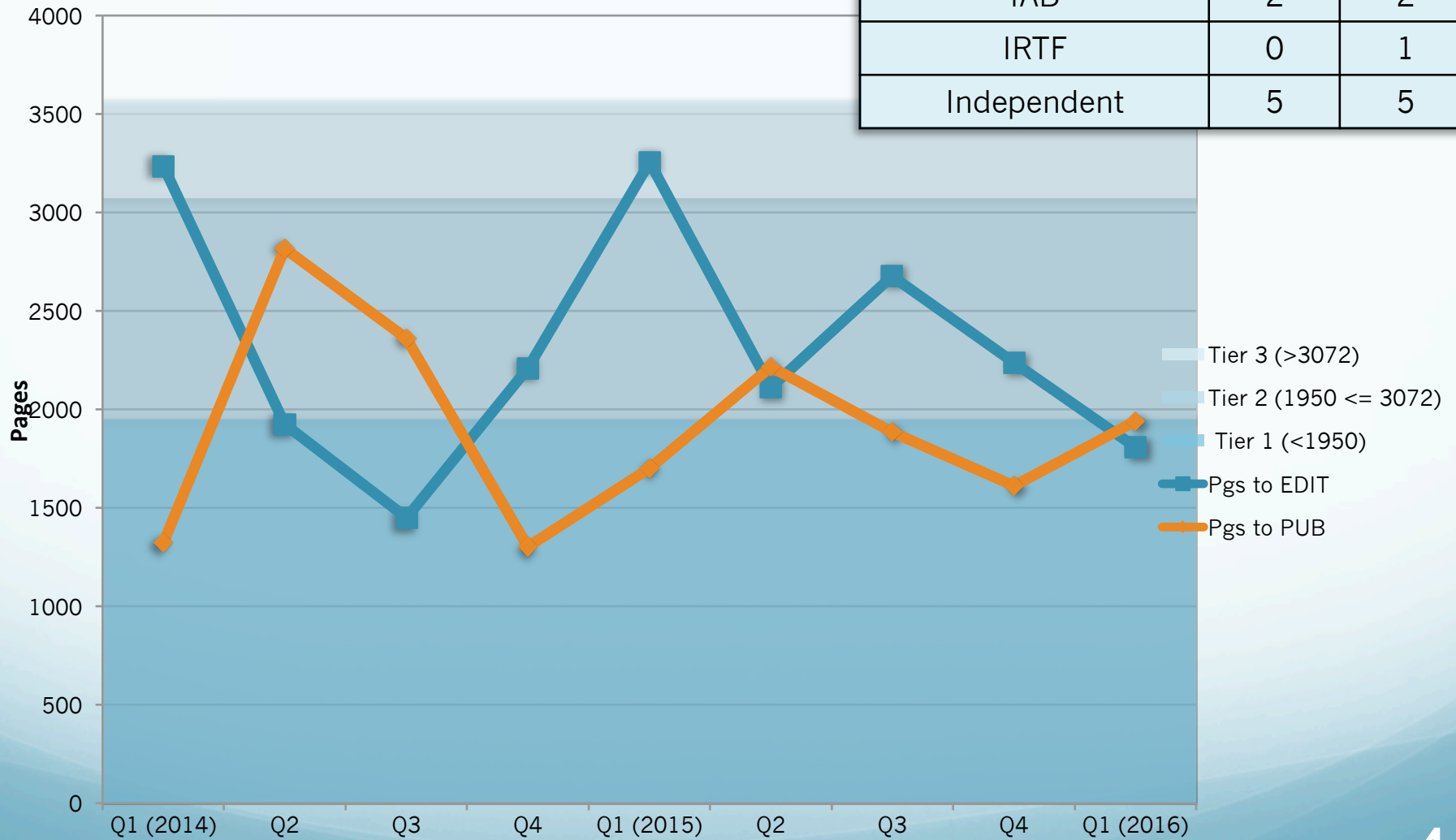

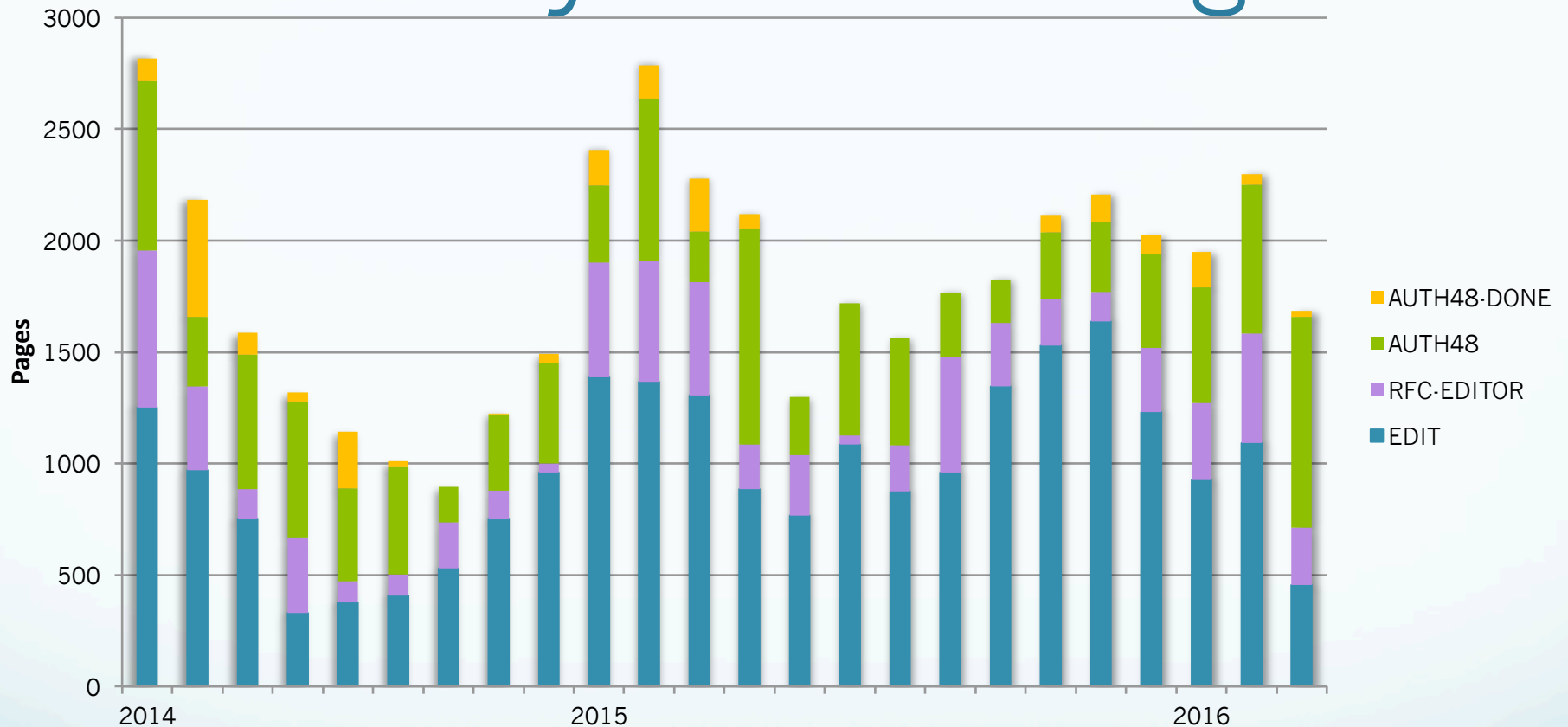

Monthly State Changes



Processing times are improving. Since Dec 2015:

- 53% fewer pages in EDIT/RFC-EDITOR
- 48% more docs in AUTH48 and AUTH48-DONE
- 48% decrease in average RET (RFC-Editor Time = EDIT + RFC-EDITOR)
Average RET as of 31 March: 3.9 wks

What's New

- Improvements to website based on community feedback
 - cluster pages: made it easier to check the I-D holding up a cluster
 - info pages: added "Discuss this RFC" (pointing to the WG mailing list, where applicable)
 - various others
- Internally: completed dev environment for website and added features on staff pages
